

## **Procedures for Indoor Visitation**

We are pleased to welcome visitors to the Holland Christian Home!

In order to comply with public health guidelines and ensure the safety of everyone in our community, the following procedures will be in place:

## **Visiting Protocol**

During indoor visitation, visitors may not walk around the facility, but rather should go directly to the resident's room / designated visitation area. Visitors should wear face coverings or masks and physically distance when around other residents or healthcare personnel, regardless of vaccination status.

If the Passaic County COVID-19 community level of transmission is substantial to high, all residents and visitors, regardless of vaccination status, should wear face coverings or masks and physically distance at all times.

If the Passaic County COVID-19 community level of transmission is low or moderate, the safest practice is for residents and visitors to wear masks and physically distance, particularly if either of them is at increased risk for severe disease or are unvaccinated.

Residents, regardless of vaccination status, can choose not to wear face coverings or masks when other residents are not present and have close contact (including touch) with their visitor.

Residents (or their representatives) and their visitors who are not up-to-date with all recommended COVID-19 vaccine doses should be advised of the risks of physical contact prior to the visit.

#### **Visiting Location**

All visits should take place in the room of the resident you are visiting. Visits should not take place in common areas, sitting rooms, or hallways. Kindly go directly to and from the room of the residents you are visiting, without stopping in hallways to visit with others.

Only two people should use an elevator at a time. If you are visiting Mountain View, please use the elevator by the Main entrance. If you are visiting Residential are, please use the West Wing Elevator. You may also use the West Wing stairwell.



# **Visitor Screening**

Please enter and exit through the Main Visitor's Entrance located at the bottom of the hill near the Graham Avenue driveway. Visitor parking is available.

Upon arriving, you will be asked to go through our normal screening procedure by showing your driver's license and receiving a Visitor's Badge that you should wear while in the building.

You will also have your temperature taken and complete a simple COVID-19 screening questionnaire. If you display any symptoms of COVID-19 or have recently been in contact with someone suspected of COVID-19 you will not be able to visit at that time.

Please note that, per state regulations, children two years of age and under are not permitted to visit indoors. All other children must wear a mask during each visit. (Outdoor visits are available for families wishing to visit with a child two years of age or younger. Please call the Activities Department at extension 612 to schedule an outdoor visit.)

After your visit, kindly return your badge to the receptionist and exit through the Main Visitor's Entrance.

Visitor should never enter or exit through another door without signing in and signing out at the Main Visitor's Entrance.
